College of Engineering, Kami Road, Sonipat.

It is intimated that the inspection committee, constituted by this University, visited your institute on dated 13-8-12 to check the compliance of previous conditions of affiliation and availability of requisite infrastructural facilities, labs, faculty and other support systems, etc. to consider the matter of continuation / extension in provisional affiliation of existing courses, increase in intake in B. Tech. in Mechanical Engineering from 60 seats to 120 seats for the session 2011-12 and introduction of new additional UG/PG courses for the session 2012-13 and has submitted the report.

The Vice-Chancellor, after considering the report, has been pleased to grant provisional affiliation for continuation / extension in provisional affiliation of existing courses with earlier sanctioned intake, increase in intake in B. Tech. in Mechanical Engineering from 60 seats to 120 seats for the session 2011-12 and introduction of new additional UG/PG courses for the session 2012-13 at P.M. College of Engineering, Kami Road, Sonipat as per details mentioned against each:

The continuation / extension in provisional of existing courses, increase in intake in B. Tech. in Mechanical Engineering from 60 seats to 120 seats for the session 2011-12 and introduction of new additional UG/PG courses for the session 2012-13, as explained above, are subject to the condition that the institute shall make full compliance of the observations made in the inspection report dated 13-8-12 within one month under intimation to the University. The above provisional affiliation is further subject to the

Further, it is made clear to the college that in the event of non compliance / fulfillment of the prescribed conditions / requirements, the University shall have the right to withdraw / refuse the provisional affiliation to the institute in the next academic session and all responsibilities arising due to such refusal / withdrawal would solely be that of the said institute / trust.

A copy of the inspection report dated 13-8-12 of the inspection committee is enclosed herewith for immediate necessary compliance alongwith supporting documents such as bills of materials / items procured, photographs of facilities created, etc.

Inspection Report

Subject: Regarding checking the compliance of deficiencies/observations pointed out by the previous inspection committee and to verify the availability of requisite infrastructural facilities, faculty, labs and other support systems to consider provisional affiliation for increase in intake in B. Tech. in Mechanical Engineering from 60 seats to 120 seats for the session 2011-12⁸² in respect of P.M. College of Engineering, Village Kami, Sonipat.

Reference No. DCRUST/CB/573 dated 01.06.2012.

In regard to above subject and reference the committee constituted for the purpose visited/inspected the said college on 13.08.2012 to verify the compliance report/infrastructural facilities etc. The point wise observations of the committee based on the physical verification of the infrastructural facilities for the proposal under reference are as under:-

- Point 1: Checking the compliance of observations regarding deficiencies pointed out by the inspection committee regarding increase in intake of existing course of B. Tech. in Mechanical Engineering from 60 seats to 120 seats for the session 2011-12⁸²
- Point 2: Checking the compliance of previous conditions for continuation / extension in provisional affiliation in respect of existing courses, i.e., B. Tech. in Civil Engg. (60 seats), Computer Science & Engg. (60 seats), Electrical Engg. (60 seats), Electronics & Comm. Engg. (120 seats) and Mechanical Engg. (60 seats plus increase in intake of 60 seats, as proposed at Sr. No. 1 above, if the same is found viable) for the session 2012-13.
- Point 3: To verify the availability of requisite infrastructural facilities, labs, faculty and other support systems, etc. in order to consider the matter regarding grant of provisional affiliation for introduction of two new additional courses, i.e., B. Tech. in Aeronautical Engg. (60 seats) and B. Tech. in Automobile Engg. (60 seats) for the session 2012-13.

Report:-

Presently the college has intake of 360 (CSE-60, CE-60, ECE-120, EE-60 and ME-60). The college needs to increase intake in Mechanical Engg. from 60 to 120 and also wants to start two new B. Tech. courses in Aeronautical and Automobile Engg. with intake of 60 in each course.

In 1st year the syllabi and laboratories are common for all discipline of Engg. & Tech. The college has sufficient infrastructural facilities to accommodate these courses with above mentioned intake.

The college has conducted interviews to select the required faculty for these courses and the appointment letter are to be issued after ensuring the strength of the students to be admitted in B.Tech second year as assured by the management of the college.

In view of the above , provisional affiliation for increase in intake in B.Tech(ME) from 60 seats to 120 seats for session 2011-12 may be granted. Also provisional affiliation for introduction of two new additional courses i.e. B.Tech in Aeronautical Engineering (60 seats) and B.Tech in Automobile Engineering (60 seats) for session 2012-13 may be granted.

The college has adequate facilities for continuation/extension for provisional affiliation in respect of existing courses i.e., B. Tech. in CSE-60, CE-60, ECE-120, EE-60 and ME-120 for the session 2012-13. *BB*


Point 4: To verify the availability of requisite infrastructure facilities, labs, faculty and other support systems, etc. in order to consider the matter regarding grant of provisional affiliation for introduction of two new additional courses, i.e., M. Tech. in Computer Science & Engg. (24 seats) and M. Tech. in Electronics & Comm. Engg. (24 seats) for the session 2012-13.

Report:-


The college may be allowed provisionally to start the M. Tech. in CSE and ECE with intake of 24 in each course after the compliance the following conditions:-


- i. The college has old version of MAT Lab software, the college should procure latest version of the said software with license of 24 users.
- ii. Rational rose software with 24 users license should be installed.
- iii. Network simulator should be installed from either open source or license version.
- iv. The college should appoint the faculty as per norms.


